All AmCham members may transition to a higher category, regardless of the revenue of the company or group to which they belong, as stated in the Membership Policy. The Membership Fee is payable within thirty (30) days of the date of the invoice submitted to the Member by the AmCham Slovenia.

**Patron**

Is a special membership category and is for all member companies that are strong supporters of AmCham Slovenia activities. Patron members are of great value to us, since their contribution and cooperation help us inspire positive change together. Patron membership represents a great opportunity for members to receive the maximum benefits out of their AmCham membership and its promotional opportunities. **Non-profit**

If your company is registered as a non-profit organization in Slovenia or the USA, the annual fee EUR 275 + a EUR 100 one-time joining fee (VAT to be added).
